## LIBERALS MUST DEMAND AMENDMENT TO BILL C-31 TO UPDATE HATE PROPAGANDA LAW

Toronto, Ontario, May 19, 2009: Last week, the Conservative government introduced Bill C-31, described as a "grab bag of changes to the *Criminal Code*"<sup>1</sup>. The Bill contains 40 legislative amendments the government claims will "fill identified gaps in the law". The government says the "proposed amendments… will help ensure that Canada's laws will continue to protect Canadians"<sup>2</sup>.

One identified gap in the law that <u>would</u> protect Canadians but is <u>not</u> included in Bill C-31, is a much-needed amendment to the hate propaganda section of the *Criminal Code* to expand the list of protected groups to include women. While ignoring this critical *Criminal Code* amendment, the Conservatives are including an amendment to the definition of prize fighting. This clearly demonstrates how skewed this government's priorities are when it comes to "protecting" Canadians.

What this situation does provide, however, is an opportunity for the opposition parties to demand a change to Bill C-31 to include an amendment to the hate propaganda law to protect women. As this is a minority parliament, Bill C-31 can't pass without opposition support. If the government does not add this amendment to their "grab bag" Bill, opposition parties can refuse to pass it.

It is particularly important for the Liberals to take action. During the last election campaign, the Liberal party promised to amend the *Criminal Code* hate propaganda law to include protection for women. Their election policy document stated:

"While the Conservatives claim that law and order is their biggest priority, they have taken no real measures to combat violence against women. A new Liberal government's efforts to fight this problem will begin with an amendment to the *Criminal Code* to include 'gender' in the hate propaganda provisions to help end societal acceptance for those who would incite hatred against women." (*Richer, Fairer, Greener: An Action Plan for the 21<sup>st</sup> Century*, Liberal Party of Canada election platform, September 2008)

Currently, Section 319 of the *Criminal Code* prohibits the public incitement of hatred against a limited list of "identifiable groups", those being set out in Section 318(4) as "any section of the public distinguished by colour, race, religion, ethnic origin or sexual orientation".

The public incitement of hatred is acknowledged to be a contributing factor in the promotion of violence and discrimination against the target group. Women are subjected to extraordinary levels of violence, and yet, for decades, politicians have refused to provide us with this basic and essential legal protection.

While the Liberal election promise was made by the previous party leader, Michael Ignatieff, the new Liberal leader, has a history as a human rights champion. For five years, he was Director of the Carr Center for Human Rights Policy. The Center's mission statement states:

"The Center uses its teaching capacity to inspire future leaders to make respect for human rights principles a central commitment of democratic leadership."

Now that Mr. Ignatieff actually holds an important position of leadership, we have every right to expect him to make women's human rights one of his central commitments. Pursuing an amendment to Bill C-31 is one step he can take. He must also maintain, as Liberal party policy, the promise to amend Section 318(4) to add women to the protected groups.
